- The RECOM system (recommendation newsletter system) is available to organizations and associations to attract new members, or to develop projects and activities publish.

- ORGA/clubs with less than 1.000 members can only use this system with costs (at reduced rates)

- ORGA/associations of 1,000 to 10,000 members receive 1 RECOM annually (international) or optionally 2 RECOM (national)
- ORGA/associations of 10.000 to 100.000 members receive 2 RECOM annually (international) or optionally 4 RECOM (national)
- ORGA/associations from 100.000 to 1.000.000 members receive 4 RECOM annually (international) or optionally 8 RECOM (national)
- ORGA/clubs over 1.000.000 receive 3 RECOM (international) or optionally 6 RECOM (national)

The condition for the use of RECOM is done by checking our scientific advisory board, whereby it is verified whether and to what extent the members the ORGA/clubs have complied with the conditions of participation.

No. 02 Participation:
